For the first Stage of refilling of the reservoir, the newly installed Radial Gates would be lowered into their desired position (crest level of 124.50 m elevation), to enable the filling process to complete within the admissible acquired land of Me.E.C.L, i.e, the level of 128.00 m elevation. **Hence, this is to request to the general public not to venture into or carry out any activities within and below the Dam reservoir level of 128.00 m elevation to prevent any untoward incidents.**


