NOTIFICATION

In line with the Board's Notification No. MeSEB/GAP/184/2008/6 dated 01.12.2008, Applications are hereby invited for registration of Contractors (Fresh & Renewal) intending to execute Building/ Civil Works under the O/o the Superintending Engineer, Shillong Civil Circle, the Executive Engineer, Shillong Civil Division- I & II, Me.P.G.C.L., Shillong in the prescribed Standard Application Form which will be issued by the office of the Superintending Engineer, Shillong Civil Circle, MePGCL Shillong for Class-II and the office of the undersigned for Class-III & IV on payment of ₹ 50/- (Rupees Fifty) only by I.P.O. pledged in favour of the Chief Accounts Officer, Me.E.C.L., Shillong w.e.f. 25th April 2017 during office hours and the last date for submission of the completed application form will be on 31st May 2017 upto 5 P.M.

For Fresh registration, the Registration Fees in the form of Bank Draft / Banker's Cheque (for Banker's Cheque only State Bank of India, Main Branch will be accepted) pledged in favour of the Chief Accounts Officer should be enclosed along with the Application Form as shown below :-

Class of Contractor	Value of Work	Registration Fees
Class II	Above ₹ 3 (Three) Lakhs upto ₹ 8 (Eight) lakhs.	₹ 15000/- (Rupees Fifteen thousand) only.
Class III	Above ₹ 1 (One) Lakh upto ₹ 3 (Three) Lakhs.	₹ 7000/- (Rupees Seven thousand) only.
Class IV	Upto ₹ 1 (One) Lakh	₹ 3000/- (Rupees Three thousand) only.

In case of indigenous tribals of Meghalaya, Scheduled Caste, Scheduled Tribe and Other Backward Classes of Meghalaya, the Registration Fees will be 50% of the amount as shown above.

The Registration is liable to be cancelled and Registration Fees forfeited in case of any false information given in the Application Form. The Registration of the Contractor is also liable to be cancelled in case of unsatisfactory performance. Incomplete Application will not be entertained.

The Registration will be applicable for the Year 2017-18 and will be valid upto 31st March 2018. The Registration should be renewed every Financial Year as long as the Contractors intend to continue to work with the Department.

The Registered Contractor who are willing to renew their registration should submit an I.P.O. of ₹50/- (Rupees Fifty) pledged in favour of Chief Accounts Officer, Me.E.C.L., Shillong along with the application form.
