Detailed Terms and Conditions for Registration of Class-I Contractors.

1. In line with the Notification No. MeSEB/GAP/184/2008/6 dt. 01.12.2008 by the MeSEB now MeECL, Application is invited for Registration of Class - 1 Contractors intending for Executing of Civil Works above Rs. 8.00 lakhs (Rupees Eight Lakhs) under the Chief Engineer (C), Maintenance & Small Hydro, Me.P.G.C.L, Lumjingshai Meghalaya, for the **Financial Year 2017 - 2018**.
2. The application form may be obtained from the office of the undersigned on payment of **Rs. 100/- (Rupees One Hundred) only** by IPO (Non Refundable) pledged in favour of the Chief Accounts Officers, Me.E.C.L, Shillong on any working day **with effect from 20th April, 2017** and to be submitted to this Office on or before **31st May, 2017**.
3. The Registration fee **Rs.30,000/- (Rupees Thirty Thousand)** in the form of Bank Draft/Bankers Cheque pledged in favour of the Chief Accounts Officer, Me.E.C.L, Shillong should be submitted along with the Application Form. The Registration Fee will be refunded on individual application if the contractor who desires to withdraw his/her registration. The Registration Fee for Schedule Caste, Scheduled Tribe and Other Backward Classes of Meghalaya will be 50 % (fifty) percent of the above amount i.e., **Rs. 15,000/- (Rupees Fifteen Thousand) only**.
4. The Registration will be applicable for the year financial year **2017-18** which must be renewed every year as long as the contractor is interested to work with the department.
5. The contractor who has registered earlier with the office of the Director Generation, Me.P.G.C.L, Shillong, may renew their Registration with the office of the Chief Engineer (C), Maintenance & Small Hydro, Me.P.G.C.L, Shillong. Renewal Application Form for the same may be received from the office of the undersigned by payment of **Rs. 100/- (Rupees One Hundred) only** in the form of IPO pledge in favour of the Chief Accounts Officer, MeECL, Shillong.
