The N.I.T. will be issued to Contractors/ Firms who have experience in executing at least 3 (three) similar works of value not less than 3.0 lakh (Rupees three lakh) only or 1 (one) similar work of value not less than 4 lakh (Rupees four lakh) previously executed by him, during the last 5 (five) years, in support of which he should submit certified copies of work orders, completion Certificates and an experience certificate signed by an Officer not below the rank of Executive Engineer.
