#### CORRIGENDUM

In line with clause 1.2.3 of section 1- Instructions to Bidders of bid documents for the tender invited vide No. MePTCL/CE(T)/TT-122/2020-21/94 Dated: 2<sup>nd</sup> June 2020 for construction of 132 kV Single Circuit Line from 132 KV Mynkre Substation to M/s Gold Stone Cement Limited Substation, amendments to the following clauses is hereby notified for information to all the prospective bidders for preparing and submission of the bid proposals.

### Section -2 QUALIFYING REQUIREMENTS OF BIDDERS

- 2.1 QUALIFYING REQUIREMENTS OF BIDDERS
- (iii) He has adequate financial stability and status to meet the financial obligation pursuant to the scope of the works. He should submit the audited turnover of the last three year and the yearly turn over should not be less than Rs. 75,60,000.00 (Rupees Seventy Five Lakhs Sixty Thousand) only.
- (iv) The contractor should also submit a list of execution details of similar nature of works, Work Order previously executed by him, for the previous 7 (seven) years as given hereunder:
  - (a) Three similar completed works each costing not less than the amount of Rs 1,00,80,000.00 being 40% of the estimated cost of Rs 2,52,00,000.00

    Or
  - (b) Two similar completed works each costing not less than the amount of Rs 1,26,00,000.00 being 50% of the estimated cost of Rs 2,52,00,000.00

    Or
  - (c) One similar completed works costing not less than the amount of Rs 2,01,60,000.00 being 80% of the estimated cost of Rs 2,52,00,000.00

In support of which, he should submit certified copies of work orders along with his tender and an experience certificate signed by an Officer not below the rank of Superintending Engineer or equivalent. After the tender has been opened, bidders may be required to submit detailed particulars of such works and the manner of their execution and any other information that will satisfy the Owner that, the contractor has an adequate organization including, experienced personnel to execute vigorously the work required to be carried out, according to the specifications.

The bidder has adequate financial solvency and liquid assets or availability of credit facilities of not less than Rs. 2,52,00,000.00 (Rupees Two Crores Fifty Two Lakh) only.
