## EXPRESSION OF INTEREST (EoI) FOR EMPANELMENT OF ADVOCATES/LAW FIRMS FOR MeECL:

- The Meghalaya Energy Corporation Limited (MeECL), is a state-owned electric utility company headquartered in Shillong, Meghalaya, India. It engages in Generation, Transmission and Distribution of Hydro-Power. MeECL has three subsidiaries, viz. Meghalaya Power Generation Corporation Limited, Meghalaya Power Transmission Corporation Limited and Meghalaya Power Distribution Company Limited.
- 2. Taking into consideration the complex needs in this direction, the MeECL is looking for empanelment of competent & experienced Advocates and/or Law firms based in India, preferably at Delhi and Shillong, for conducting its cases in various Courts/Tribunals/Forums/Authorities by and on behalf of the MeECL, for drafting and vetting various agreements and contracts and for conducting due diligence exercise etc. The services of Advocates/Law firms will be mainly utilised in the matters/litigation work being contemplated at various forums i.e. Hon'ble Supreme Court of India; Hon'ble Electricity Appellate Tribunal Delhi; Central Electricity Authority Delhi, Central Electricity Regulatory Commission Delhi; Hon'ble High Court of Meghalaya, State Electricity Regulatory Commission Shillong; Industrial Tribunals in Delhi and Meghalaya, National Consumer Disputes Redressal Commission Delhi, State Consumer Commission, Shillong District Consumer Forums in Meghalaya and various Commissions & Other Quasi-judicial bodies in matters relating to Electricity law and disputes, service matters and disputes, contractual disputes (excluding Arbitration), Estate related matters, RTI matters at CIC Delhi and State Commission at Shillong etc. as per requirements of the MeECL, Shillong, Meghalaya and other place in the Country as may be required.
- 3. The Meghalaya Energy Corporation Limited invites Expression of Interest Applications" from interested Advocates/Law Firms for the Scope of Work (SoW) which inter-alia includes the following:-
  - Rendering legal services and providing opinion, as and when referred, on matters related to Electricity
    laws, Service laws, contractual matters (excluding Arbitration), consumer laws, property and estate
    matters, RTI matters etc. besides other litigation matters that may be referred from time to time.
  - Handling notices and other legal queries, in the above areas as and when referred.

- Conducting legal due diligence, as and when referred.
- Providing legal opinion, advice related to Legal matters of the Corporation as and when referred.
- Legal Vetting of draft notices, agreements, bidding documents, MoAs, MoUs etc.

## 4. Essential Eligibility Criteria

- i. The responding Advocates and/or Law Firms should be registered under the Statutes of India.
- ii. They should be having office in India, preferably in Delhi and/or Shillong. If they have office in Delhi, at least one qualified Advocate registered under the statutes of India, shall be deputed/made available at Shillong as and when required by the Corporation and similarly if they have office at Shillong, at least one qualified Advocate registered under the statutes of India, shall be deputed/made available at Delhi as and when required by the Corporation.

iii.Advocates/Law Firms should possess minimum experience of Seven years in representing Government Departments/Government Companies/Autonomous Bodies in Contractual Disputes, Service matters etc.

- iv. Advocates/Law Firms must have the requisite infrastructure and in-house capability.
- v. Advocates/Law Firms should possess professional expertise especially in handling cases in the areas stated above.
- vi. Advocates/Law Firms should not have been debarred by any Central/State Government/University/Government Departments.

# 5. Correspondence with Applicant

Given and except as provided in EoI, the MeECL shall not entertain any correspondence with any applicant in relation to the acceptance or rejection of any application. MeECL, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time to:

- (a) Suspend and/or cancel the EOI process and/or amend and/or supplement the EOI process or modify the dates or other terms &conditions relating there-to.
- (b) Consult any applicant in order to receive clarification or further information.
- (c) Empanel or not to empanel any applicant.

- (d) Retain any information and/or evidence submitted to the MeECL, on behalf of, and/or in relation to any applicant and/or.
