The final reports preceded exhaustive submission of documents by MePGCL to the mentioned organizations, numerous discussions across the table and a number of site visits. Three groups of officers from MePGCL undertook visits to Roorkeg. IIT at different dates and there were 2 (two) visits by the Faculty members of Roorkee IIT to Myntdu Leshka HEP sites.

In all, 4 (four) meetings were held among the members of the technical committee the minutes of each of which is attached herewith.

Based on the study of the documents, the discussions on the entire gamut of the project execution, site visits and final reports from the respective authorities, it can be concluded that:-

- 1. The main Project components were generally executed as per construction drawings received from Central Water Commission and Central Elegisicity Authority.
- 2. The realization of the impact of acidity of water and the preventive measures adopted were in line with the recommendations of authorities like Central Soil and Material Research Station (CSMRS) and other authorized consultants.
- 3. The payment have been made as per conditions of agreement and sanctions accorded by the competent authorities of the Project.
