EMPANELMENT OF VENDORS FOR SUPPLY OF SMART ENERGY METERS

1.0 INTRODUCTION

1.1 Meghalaya Power Distribution Corporation Limited (MePDCL), having its Registered office at Lumjingshai, Short Round Road, Shillong – 793001, (hereinafter referred as Owner), is supplying Electricity to domestic, commercial and Industrial consumers intends to upgrade the network to replace old Energy Meters with Smart Energy Meters and in Future all the new and old Domestic, Commercial and Industrial consumers will only use Smart Energy Meters. Now as per the recent instructions from Ministry of Power all energy meters must be replaced with prepaid smart meters in the whole country.

1.2 Material Management Department has been appointed as Nodal Department. (herein after referred to as MM), by MePDCL for afore mentioned empanelment in which MePDCL intends to empanel vendors for supply of Smart Energy Meters.

2.0 ELIGIBILITY CRITERIA

2.1 Interested bidder must have supplied minimum 10000 numbers of Smart Energy Meters in last 1 year.

2.2 Bidder must have valid type approval certificate as per IS16444 at the time of bid submission.

2.3 Bidder must have experience of Integration of Minimum 10000 GPRS Based Smart Energy Meters with Head End System.

2.4 Net worth of bidder must be positive for FY 2019-20

Note:

A. Bidder shall submit minimum following documents to establish their credentials to meet Eligibility criteria

1). Purchase order copy mentioning clearly above eligibility criteria

2). Copy of SOR of above purchase order clearly describing the scope of supply,

3). Certificate from owner certifying supplied quantity against the said PO and the duration during which this supply took place,

4). Copy of valid Trade certificate issued by District Councils, Meghalaya on becoming successful vendor.

5). Copy of audited financial report for FY 2019-20,

6). Form for Empanelment.

B. The bidder is required to submit the documentation and proof for above requirements to owner and MePDCL may at its discretion make additional checks for the same.

C. The offer shall be submitted to the Owner in a sealed envelope super scribing Ref. No. – EOI/EMPANELMENT/SMART METERS/05/2021 and type of Smart Meters (Single Phase, Three Phase, LT-CT Meters, HT Meter with MODEM) for which offer has been submitted.

3.0 Proposals complete in all respects should be submitted to Additional Chief Engineer (MM), at Lumjingshai, Short Round Road, Shillong – 793001, Meghalaya India.
