- **Other terms and conditions of the EOI dated 24th January, 2022 shall remain same.**



- Query of Bidder: With reference to EOI MeECL/CS/RFP/2015/2061 Dated 24th January 2022, We would like to know that whether price bid to be Quoted along EOI:

Clarification: Pl refer clause no.9 'tendering process' of the tender document dated 24th January, 2022.

- Query of Bidder: We have gone through EOI for Engagement of Chartered Accountant firm (Consultant) to prepare and finalize the Quarterly, Half Yearly and Annual Accounts of the MeECL and its three Subsidiaries for Financial Year 2021-22 (IND AS). The Assignment is for FY 21-22 of which three (3) quarters and one (1) Half year have already been elapsed.. Our Query is whether the assignment is for FY 21-22 or FY 22-23 or for both. If the Assignment is for FY 21-22, then what is the time limit for submit report for the 3 quarters and 1 half year which is already elapsed

Clarification: The assignment will be for one year period i.e. preparation of four quarterly accounts, two half yearly accounts and one final annual accounts for MeECL and its three subsidiary companies. The assignment may go beyond the period of FY 2021-22.

- Query of Bidder: However, Due to lack of information (other than turnover) about your organisation, we are unable to arrive at a reasonable price to be quoted for the said work.
