The Registration is liable to be cancelled and Registration Fees forfeited in case of any false information given in the Application Form. The Registration of the Contractor is also liable to be cancelled in case of unsatisfactory performance. Incomplete Application will not be entertained.

The Registration will be applicable for the Year 2022-23 and will be valid till renewal of registration for next year i.e 2023. The Registration should be renewed every Financial Year as long as the Contractors intend to continue to work with the Department.
