- In line with the Notification No. MeSEB/GAP/184/2008/6 dt. 01.12.2008 by the MeSEB now MeECL, Application is invited for Registration/Renewal of Class – 1 Contractors intending for Executing of Civil Works above Rs. 8.00 lakhs (Rupees Eight Lakhs) only, under the Chief Engineer (C), Maintenance & Small Hydro, Me.P.G.C.L, Lumjingshai Meghalaya, for the year 2020 – 2021.
- 2. The Application Form for Fresh/Renewal may be downloaded from the official website www.meecl.nic.in w.e.f 0-00 hrs of 11th of April, 2022 to 4-00 PM of 16th of May 2022. The Application form complete in all respect, attached with a Non-refundable Banker Cheque/Demand Draft/I.P.O of Rs. 200/- (Rupees Two Hundred) only pledged in favour of the Chief Accounts Officers, Me.E.C.L, Shillong is to be submitted to this office on or before 4-00 PM of 16th of May, 2022.
- 3. For Fresh, the Registration fee of Rs.30,000/- (Rupees Thirty Thousand) only, in the form of Bank Draft/Bankers Cheque alongwith Banker Cheque/Demand Draft/I.P.O Rs. 200/- (Non Refundable), pledged in favour of the Chief Accounts Officer, Me.E.C.L, Shillong, should be submitted along with the Application Form.
