

Sub: Cancellation of Expression of Interest for leasing of dark fibres of OPGW under MePTCL.

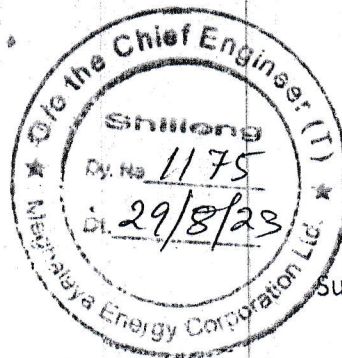

Sir,

In line with the Guiding Principles for Monetization of Transmission Assets in the Public Sector through Acquire, Operate, Maintain and Transfer (AOMT) based PPP model issued by the Ministry of Power vide No. 25-10/28/2021-PG dated 03.10.2022, MePTCL has decided to monetize its available OPGW fibre network to unlock the value of the transmission asset from public investment and tapping private sector flexibilities in operations and management of infrastructure.

In line with the above for value maximisation of assets as well as Clause 12.0 of Section II of the referred EOI, this is to convey the approval of the Director Transmission to cancel the EOI for leasing of spare dark fibres of OPGW available in MePTCL's Optical Fibre network which was floated vide the above referred notice.
