Minutes of meeting of TC & TEC on the Evaluation of Financial bids against Appointment of System Integrator (SI) for implementation of Utility Billing System under SaaS Model under Revamped Distribution Sector Scheme (RDSS) held on 13th September, 2023 at 16:00 Hours held in the Conference Room, MeECL, Shillong.

Member present: As per Annexure-II.

At the outset the Chairman of Tender Committee, Director (Distribution) welcomed all the members of TC & TEC present in the meeting and informed that the meeting is meant to discuss the Financial Evaluation of the tender for Unified billing System (UBS). He then requested the Chief Engineer (Projects) for further deliberation.

The Chief Engineer (Projects) informed that the financial bids of the two bidders, namely; (i) M/s Idea Infinity IT Solution Private Limited and (ii) M/s Inventive Software Solution Pvt Ltd were opened on 04.08.2023.

It was also informed that M/s Inventive Software Solution Pvt Ltd has not submitted the financial bid as stipulated in pre-bid clarification of the Bid Document / RFP. The bidder has not submitted the bid in pdf format as stipulated in the clarification issued that the bidder has to submit with Table-1, Table-2, Table-2(a), Table-2(c), Table-2(d), Table-2(e), Table-2(g). The bidder has submitted the financial bid only in the excel sheet BOQ which was clearly mentioned that the excel sheet BOQ shall not be considered for price evaluation and that only the PDF format which the bidder uploads in the Financial Proposal Envelope shall be considered for price evaluation. As such, the financial bid of M/s Inventive Software Solution Pvt Ltd is non-responsive and was not considered for evaluation.

However, the financial bid of M/s Idea Infinity IT Solution Private Limited is in order. Therefore, only the financial bid of M/s Idea Infinity IT Solution Private Limited, was considered for evaluation and the evaluation was carried out under Section – 3: Instructions to Bidders and Bid Data Sheet Clause 23, Evaluation of Financial Bids / Proposals and the details are as indicated in Annexure-I.

After thorough deliberation, the Tender Committee unanimously agreed and noted that the financial bid of the bidder, namely M/s Idea Infinity IT Solution Private Limited is in order and that the overall evaluated price of the bidder is as per their quoted price as follows:
