### Terms & Conditions for acquiring Condemned Vehicles (lying in different offices) under MeECL by Employees.

- 1. Sealed Quotations / Offers (in prescribed format Annexure-II) are invited from the employees of MeECL interested in acquiring condemned vehicles under MeECL.
- The list of condemned vehicles with details viz. Model, type, minimum assessed/ estimated values, custodian of vehicles etc. are indicated in Annexure-I attached with the Notification.
- 3. Interested employees can download the Notification along with the Annexures from the MeECL website at <a href="https://www.meecl.nic.in">www.meecl.nic.in</a> wef 9<sup>th</sup> July, 2024.
- The condemned vehicles can be inspected & assessed physically on the spot by the interested employees by showing ID proof to the Custodian of these vehicles wef 10<sup>th</sup> July, 2024 to 19<sup>th</sup> July, 2024 (excluding Saturday, Sunday & Holiday).
- 5. The Sealed Quotations /Offers (in prescribed format Annexure-II) duly signed by the employees with ID No. can be submitted to the office of the undersigned on working days wef. 22<sup>nd</sup> July, 2024 up to 24<sup>th</sup> July, 2024 (up to 16:30 Hrs). No offer will be entertained after the specified date & time.
- The employees shall quote / offer rates which shall be at par or higher then the
  minimum assessed/ estimated value against the vehicle as indicated in the format,
  which is inclusive of GST.
- 7. The interested employees are eligible and can offer /Quote Rates for 1(one) or multiple number of vehicles as per format (Annexure-II) attached.
- 8. In case, if only one bidder/employee quoted / offered Rates for condemned vehicle(s) without competition from other Bidder(s), that particular Bidder shall be rightly selected as a successful Bidder, provided the Rate quoted/Offered is/are at par or higher than the estimated/assessed value.
- 9. In case, if 2 (two) or more Bidders Bid for particular vehicle at the same Rate, decision to determine the successful Bidder shall be through draw of **lottery or toss of a coin**.

- 10. The process of selection shall be at the responsibility of MeECL, and the highest Bidder (H-1) will be preferred.
- 11. Notification /Intimation letter to the Successful Bidder(s)/ highest Bidder(s) will be issued by this office to complete submission of payment of offered amount.
- 12. The Successful Bidder(s) shall deposit the quoted /Offered value by Demand Draft in favour of "the Principal Account of MeECL" Shillong within 7(seven) days from the date of Notification / Intimation to the successful Bidders, to the office of the undersigned for confirmation of payment by concerned department.
- 13. In case the successful Bidder does not respond within a period of 7 (Seven) days time, the next higher Bidder (H2) will be offered/ intimated for the same vehicle, provided the rate shall be higher than the minimum estimated value.
- 14. The lifting order will be issued by the Additional Chief Engineer (MM) only after confirmation of full payment received from the successful Bidders (in the form of DD) from the Accounts Department.
- 15. Within a period of **10** (**ten**) **days** of lifting order of condemned vehicle(s) issued, the successful / awarded Bidder(s) has/have to lift the vehicle (s) from the custodians (as is where is) at the cost of the employee(s).
- 16. Once the condemned vehicles have been lifted by the awarded/successful Bidders within the specified time, risk & responsibility of the MeECL shall cease immediately.
