ORDER U/S 163 OF BHARATIYA NAGARIK SURAKSHA SANHITA, 2023

Whereas, it is reported to the Undersigned that the area surrounding the New Umtru Hydroelectric Project (HEP) at Byrnihat, Ri Bhoi District, constructed across the Umtru River, has become a popular gathering spot, particularly on weekends, Sundays, and public holidays, which raises significant concerns regarding public safety.

And whereas, reports have also indicated incidents of drowning and other related accidents in the past, thereby necessitating the restriction of public access and the prevention of public gatherings in the zone to avert any further unfortunate incidents.

And whereas, I am of the opinion that immediate preventive measures must be implemented to ensure public safety and to prevent any untoward incidents.

Now, therefore, I, Shri. Abhilash Baranwal, IAS, District Magistrate, Ri Bhoi, in exercise of the powers conferred upon me under Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023, and in the interest of public safety and security, hereby prohibit public access in the area surrounding the New Umtru Hydroelectric Project (HEP), Ri Bhoi District, including its downstream flood zone, to prevent any untoward incidents.

Any person found contravening this Order shall be liable for legal action under Section 223 of the Bharatiya Nyaya Sanhita, 2023.

This order shall be enforced by the District Police of Ri Bhoi District and the Offices of the Additional Chief Engineer (C), HP, MePGCL, Umiam, and the Chief Engineer (HP&HC), MePGCL, Shillong and office of BDO, Umling C & RD Block.

This Order shall take effect immediately in the prohibited zone mentioned above, until further orders.
