Notification

The Meghalaya Power Distribution Corporation Limited (MePDCL) announced the extension of "One Time Settlement (OTS) Scheme 2025" for "Domestic Low Tension (DLT)" and "Kutir Jyoti/ BPL" Consumers having declared load of 5(Five) KW and below for disconnected consumers due to non-payment, to recover long outstanding dues of electricity bills for another period of 1(one) month with effect from 1st April, 2025 to 30th April, 2025, on the following terms and conditions:

1. The One Time Settlement (OTS) Scheme, 2025 will be extended from 1st April, 2025 to 30th April, 2025. Only disconnected consumers are eligible to apply for OTS Scheme 2025 and avail the benefit.

2. To avail the benefit of the OTS Scheme 2025, the consumers can submit an Application to the Assistant Executive Engineer (AEE) of the concerned Distribution Sub-Division. The Assistant Executive Engineer (AEE) will process the application and generate the OTS in the billing software.

3. Consumers who are willing to avail the OTS Scheme 2025 will benefit with 100% Delay Payment Surcharge (DPC) waiver calculated up to the latest bill as on the date of availing of OTS Scheme 2025.

4. For the balance amount after deducting the DPC amount, the consumer can opt to pay in either of the two options:

a. Onetime Payment or

b. In up to 6(six) equal instalments which is interest free. However the first instalment would be 40% of the balance amount, the remaining 60% of the balance would be divided in 5 (five) equal instalments.

5. In case the consumer opts for instalment these instalments will be added as additional amount to be paid for OTS and served along with the current bill. And the Due date for

payment of the instalment will be the same as the current bill.

6. In the event of default of instalment payment, the entire DPC will be reactivated along with the balance instalment and added to the current bill.

7. This OTS Scheme 2025 is however not applicable for the following consumers:

7.1. Any surcharge/penalty accumulated against bills raised for any theft, meter tampering or any other malpractices.

7.2. For the Consumers who are presently paying their dues as per some settlement Scheme/agreement with the Corporation

7.3. Issues which are in the court of law, Regulatory Commission or any such Authority.
