Expression of Interest from the Transformers Repairing Firms

- 1. Invitation as per Notice No.ACE(MM)/EM/TRF/2025-256 Dated: 12th June 2025.
- 2.Scope: Empanelment of firms interested for partaking in future tender/work for 'Repairing of failed Transformers for 11KV and 33KV Level under MePDCL, Eastern Zone and Western Zone. Location of a firm shall be only from the State of Meghalaya and Assam'.
- 3. Criteria of Requirement: For a firm to get empanelled under this scope, the following minimum documents/requirements must be fulfilled:
 - i. Registration document
 - ii. Licence to work at factory
 - iii. Memorandum of Articles of Association/Proprietorship/Partnership
 - iv. GST, PAN Card
 - v. Clearance Certificate from State Pollution Control Board/Any related Authority.
 - vi. List of machineries.
 - vii. Testing equipment.
 - viii. Calibrated meters
 - ix. Past Experience/past order of similar work (last 3 years)
 - x Performance Certificates of the executed work (last 3 years)
 - xi Approved GTPs and Drawings s of the Transformers executed as per Sl. No. (ix).
 - xii. Documents of skilled and semi-skilled workers.
 - xiii. All the documents shall be up dated and valid from time to time.
 - xiv. Documents from SI. Nos. (i) to (v) are required to establish the clear existence of a firm under recognition by the state government.
 - xv. Documents from SI. Nos. (vi)to(viii) are required to establish the authenticity of machineries, testing equipment and the maintenance/observation of sensitivity of the reading meterswith supporting of valid Certificates from NABL accredited labs.
 - xvi. Documents from SI. Nos. (ix) to (xi) are required to establish the experience of the firm which is very crucial for observation of the quality of works being executed by a firm.
 - xvii. In case a firm apprise as a start-up firm, supporting documents must be furnished. However, documents from SI. Nos. (i) to (viii) shall have to be furnished without fail.

4. Stages of Qualification

- i. The First stage of empanelmentprocess will be examination/fulfilment of documentation.
- ii. The Second stage of empanelment process will be factory inspection.
- iii. The Third stage of empanelment process will be issuing of Approval Letter based on the Satisfactory Report submitted by the Inspecting Officer.
- 5. SOP: The following SOP will be maintained/conducted during empanelment period:
 - i. All documents shall be submitted within 1 month from the date of floating of EOI
 - ii. Within this period, the intending firm may seek clarification/query to clear all doubts. All queries shall reach the O/o the ACE(MM) within 7 (seven) days before the last date of submission of documents. The firm may contact e-mail ace.mm.meecl@gmail.com for queries and clarifications.
 - iii. After examination of documents, clarifications and queries may be raised by the Department.
 - iv. When documentation has been completed in all respect, this means the 1st stage of empanelment has been completed, the Department will inform the firm accordingly
 - v. The firm will then invite the Department for factory inspection. The date of the program shall be fixed at mutually convenient time of both parties.
 - vi. Afterfactory inspection, the firm will get the empanelment based on the satisfactory report submitted by the Inspecting Officer.
