## CHANGE OF FRANCHISEE OPERATOR FROM "FEEDBACK ENERGY DISTRIBUTION COMPANY LIMITED (FEDCO)" TO "SAI COMPUTER LTD" w.e.f 01.11.2025"

To our valued Consumers of Meghalaya Power Distribution Limited (MePDCL),

The Meghalaya'Power Distribution Corporation Limited (MePDCL) has in the year 2019 awarded the Contract to Feedback Energy Distribution Company Limited (FEDCO) for Operation, Maintenance and Supply of Electricity in the Distribution Franchisee Area, such as, Mawsynram Revenue Section, Phulbari Revenue Sub Division and Nongalbibra Revenue Sub Division respectively.

However, due to continuous default on the part of M/s FEDCO to Operate and Maintain proper power supply in the entire Distribution Franchisee Area, the MePDCL has terminated the contract with FEDCO w.e.f 01.11.2025.

Therefore, "FEDCO" will no longer be operating the Distribution Franchisee Areas falling under Mawsynram Revenue Section, Phulbari Revenue Sub Division and Nongalbibra Revenue Sub Division respectively with effect from 01.11.2025.

M/s. Sai Computer Ltd. will be taking over the operations of the Distribution Franchisee Areas with effect from 01.11.2025. Billing, Collections and Supply of Electricity shall henceforth be operated by Sai Computers Ltd. in the entire Franchisee Areas.
