Security Deposit: Rs 1,00,000/- (For ST/SC/OBC) & Rs 2,00,000/- for General Applicant (Refundable on withdrawal of Registration) in the form of Call Deposit / Fixed Deposit in favour of ACE, Material Management, MeECL with a validity of 2(two) Years. Previous Security Deposit of existing Registered Suppliers will be return after completion of Registration process.

Audited Balance Sheet: Optional for existing Registered Supplier.

Bank Solvency Certificate: From Nationalized/Scheduled Bank: Rs 50/- Lakhs for Large Scale, Rs 7.5 Lakhs for Small Scale, Rs 5.0 Lakh for Other Category (Optional for existing Registered Supplier)

Experience Certificates: Optional for existing Registered Suppliers

Other Conditions:

- Only 1(one) GST No will be allowed to register/Renew in the category of Electrical Items both for Small & Large-Scale Suppliers.
